Windows - Existing homes only

For window rebates usage must be over 8,000 kilowatt-hours of electric straight resistance heat or over 340 therms for natural gas customers.

Windows are defined by glass and frame. Licensed contractor must provide new window documentation to include an **itemized invoice with the following: total window square footage, u-factor, ratings, and cost.**

Storm windows (interior/exterior) must be new, the same size as existing window, not in direct contact with existing window, and exterior windows low-e coating must be facing the interior of the home. Glazing material emissivity must be less than .22 with a solar transmittance greater than .55.

Conversions from Electric - Existing homes only

Conversion rebates are available to Avista electric customers who replace electric straight resistance as their primary heat with natural gas heat.

Customer usage will be reviewed and must demonstrate that at least 8,000 kilowatt-hours of electric straight resistance heat and less than 340 therms occurred in the last 12 months in order to be eligible for rebate. Please call Avista to pre-qualify your project, if you would like Avista to pre-approve annual usage please call us at 1-800-227-9187, or email rebates@myavista.com.

- Electric Central Ducted Forced Air Furnace to Air Source Heat Pump — \$700
- Electric Baseboard heat to Natural Gas Direct Vent Wall Heater or Stove — \$1,300 (Must be controlled via thermostat)
- Electric Heat to Natural Gas Furnace — \$1,500
- Electric Baseboard Heat to Ductless Heat Pump — \$500 (Must be primary heat source with a 9.0 HSPF or greater)
- Electric to Natural Gas Furnace and Water Heat Combo — \$2,250

Additional Conditions

- Primary fuel used for space heating must be Avista electric or natural gas service to qualify.
- Request for rebates must be submitted within 90 days of completion of energy efficiency measure.
- The rebates are available for primary residential single family up to a fourplex, including manufactured and modular homes.
- Rebates are not available for seasonal or recreational homes or condos.
- Only new equipment qualifies.
- All improvements must be contractor installed (smart thermostat exception) to be eligible for rebate consideration.
- Homeowners are responsible for complying with all applicable codes and regulations.
- Efficiencies for space and water heating equipment are verified according to the contractor invoice or Air-Conditioning, Heating, and Refrigeration Institute certification (AHRI). www.ahridirectory.org
- Avista reserves the right to verify installation of the energy efficiency measure(s) prior to payment and will coordinate inspection as applicable.
- Avista, and its agents, may upon reasonable notice, request access to customer's premises after payment, for evaluation and measurement purposes.
- Rebates will not exceed 100% of the actual measure cost.
- Rebates are paid directly to homeowner or homeowner can authorize payment release to contractors.
- Allow 8 weeks for processing and payment of rebate checks.

I also request that any qualifying allowance that may be available and applicable under Avista's Washington Line Extension Allowance Program (the "Program") be made payable and sent to the vendor identified below. By signing this Release, I understand and agree that (i) Avista will make the final determination on any allowance I may be eligible to receive under the Program; (ii) the Program is subject to change without notice; and (iii) I have signed a Line Extension Allowance Agreement, which governs any and all allowances that may be available under the Program; and (iv) I acknowledge my understanding that, by signing this Release, I will not receive a Check, but that any allowance that may be available will be made payable and sent directly to the vendor.

I understand that releasing the incentive payment to the vendor does not exempt me from the Energy Efficiency Program requirements outlined in my Incentive Agreement with Avista. Further, I understand that this Release will not be applicable until or unless Avista approves same, evidenced by Avista authorized signature on page one.
