



Residential Energy Efficiency Rebates

Rebate Requirements

Electric to natural gas furnace conversion eligibility still requires customer to heat primarily with electric straight resistance. Customer usage will be reviewed and must demonstrate that at least 8,000 kilowatt-hours of electric straight resistance heat and less than 340 therms occurred in the last 12 months in order to be eligible for rebate. For weatherization rebates usage must be over 8,000 kilowatt-hours of electric straight resistance heat or over 340 therms for natural gas customers.
